- Weather Rules: Lightening, must wait 30 minutes, it is only the official's jurisdiction to end game for unsafe conditions

Tactical Fouls

- A foul that is made to intentionally stop a scoring play
- When does it warrant a card?

Playoffs:

- If there is an issue Coach has to say "I want to protest" at the next stoppage, you ask the coach what they are protesting and write it in the book for play ins and quarters
- Board doesn't have headsets, but if headsets at supplied you must use them.
